

## **Product Classification Certification**

## DOWNLOAD TO YOUR DESKTOP BEFORE COMPLETING FORM

## Please read the following in its entirety before completing the form

The University of Arkansas Fayetteville is requesting that you, the vendor/manufacturer of the item(s) being procured, supply the export classification as it pertains to the appropriate regulation (EAR <sup>1</sup>/ITAR<sup>2</sup>) of each item on the invoice. Per 15 CFR 758.3, it is the responsibility of the manufacturer or supplier, not the buyer or freight forwarder, to identify the export classification of items being procured. This is because neither is in a position to understand the technical assessment of the item(s) and/or the original design intent (ODI) in order to determine the correct classifications. Please note that the University of Arkansas Fayetteville is not asking your company to apply for an ECCN, or license. University of Arkansas Fayetteville is simply asking your company to identify the level of control associated with the product(s) you are selling, so that we may appropriately adhere to U.S. laws and regulations. This includes items that fall into the designation of "EAR99". If your organization is outside of the U.S., you may use the Wassenaar Arrangement<sup>3</sup> guide for identifying the classification.

If your organization does not have export classification determinations within your product management system, the U.S. Department of Commerce has an online decision tool available to assist you called the "CCL Order of Review" (<a href="https://www.bis.doc.gov/index.php/decision-tree-tools">https://www.bis.doc.gov/index.php/decision-tree-tools</a>). You may also contact a BIS Export Counselor at (202) 482-4811 for guidance in determining your product's export control classification number. For USML classifications, The Directorate of Defense Trade Controls also has an online decision tool available to assist you called the "U.S. Munition List (USML) Order of Review Decision Tool" (<a href="https://www.pmddtc.state.gov/ddtc.public?id=ddtc.public.gov/">https://www.pmddtc.state.gov/ddtc.public.gov/</a> ddt order of review).

We are also requesting that in addition to the export classification, the U.S. Harmonized Tariff Schedule (US-HTS) is provided. You may find an online resource from the United States Trade Representative to be of some assistance (<a href="https://ustr.gov/callout/us-harmonized-tariff-schedule-hts">https://ustr.gov/callout/us-harmonized-tariff-schedule-hts</a>). Used in conjunction with the U.S. International Trade Commission's official HTS (<a href="https://hts.usitc.gov/current">https://hts.usitc.gov/current</a>), you will be able to identify the complete 10-digit code easily.
